said Irene Tusken being then and there a female of upwards of
ten years, to-wit: of the age of eighteen years, and the said
Irene Tusken not being then and there the wife of the said
Nate Gray; the resistance of the said Irene Tusken to the said
sexual intercourse being then and there forcibly overcome, and
being then and there prevented by fear of immediate and great
bodily harm which she then and there had reasonable cause to
believe would be inflicted upon her,
